## Lifetime mount registration information and application

**Please read all information carefully before filling out form!**

- Any equine can be eligible for ACTRA awards and mileage accumulation for a one-time fee of \$25. The number will remain with the horse throughout his/her lifetime and can be re-registered to a different owner for a nominal fee of \$2.
- The **ride season** runs from November 1<sup>st</sup> of the previous calendar year to October 31<sup>st</sup> of the current calendar year. If you wish to register your mount for the current ride season please do so before attending your first ride as miles and points achieved prior to registration will not count towards year- end placings.
- If you are registering a mount, and that mount collected ACTRA sanctioned miles in the previous ride season, you may claim those miles by submitting a letter listing the name and date of all rides completed by the equine to the statistician **before** October 31<sup>st</sup> of the current calendar year/ride season. **Failure to do so will result in forfeiture of those miles.**
- Any ACTRA registered mount may collect outside miles, (those sanctioned by other competitive distance riding organizations outside Atlantic Canada) completed within the **current** ACTRA ride season, by submitting ride name, date, and proof of completion along with a fee of \$10 dollars per ride to the treasurer **before** October 31<sup>st</sup> of the current calendar year/ride season. **Failure to do so will result in forfeiture of those miles.** If a member is claiming miles along with the mount they need only to send \$10 in total.
- If your mount belongs to a breed registry association you must submit a copy of the breed papers with the lifetime mount registration form. Failure to include the papers will result in the horse being ineligible for any awards associated with his/her breed.
- **The one-time fee must accompany the registration form in order to be valid.** You may scan and email a completed form and a copy of the breed papers if applicable, along with an e-transfer to the current ACTRA treasurer **OR** send a cheque/money order and all applicable paperwork via Canada Post.
